Santanna Energy Services Customer Rewards Program Terms and Conditions

1. Introduction

Welcome to the Santanna Energy Services Customer Rewards Program ("Program"). By participating in this Program, you agree to comply with and be bound by these terms and conditions ("Terms"). Please read them carefully. If you do not agree to these Terms, you may not participate in the Program.

2. Eligibility

2.1. **Participation Requirements:** The Program is open to all existing and current customers of Santanna Energy Services who are at least 18 years of age and residing in the United States. Void where prohibited.

3. Program Entry

3.1. **Manual Entry Required:** Customers are not automatically entered into the Program. To participate, eligible customers must manually submit an entry available via email (email reminders will be sent each month), or via Santanna's Online Customer Portal in order to be eligible for that month's drawing. Only one entry is allowed per customer account per month. No purchase or consideration is necessary to enter or win.
